# FARMINGTON BOARD OF SELECTMEN

# Tuesday, May 19, 2015

Chairman Joshua Bell called the meeting to order at 6:30 p.m. with the following members present: Stephan Bunker, Michael Fogg, Andrew Buckland and Matthew Smith. Town Manager Richard Davis, Town Secretary Linda Grant, Fire Rescue Chief Terry Bell, Police Chief Jack Peck, Deputy Chief Shane Cote as videographer for Channel 11, Parks & Recreation Director Steve Shible and Assistant Director Matthew Foster, Public Works Director Denis Castonguay, and members of the press and public were also in attendance.

# **ITEM 1: Pledge of Allegiance to the Flag**

Chairman Joshua Bell led those present in the Pledge of Allegiance to the Flag.

- ITEM 2: To Hold a Public Hearing and vote on the Following Renewal Applications for Innkeeper and Lunch Wagon Permits:
  - Farmington Motel, Located at 489 Farmington Falls Road, owned and operated by Rushi, LLC
  - Mount Blue Motel, Located at 454 Wilton Road and Colonial Valley Motel, Located at 593 Wilton Road, owned and operated by Rick Collins
  - RJ's Hot Dogs, owned and operated by Richard Joseph Sr.
  - Grantlee's Mobile, owned and operated by Bernard Bates

Chairman Joshua Bell opened the Public Hearing under Item 2 at 6:31 P.M.

Richard Davis stated that all five applications are routine annual renewals.

Chairman Joshua Bell closed the Public Hearing under Item 2 at 6:34 P.M.

Stephan Bunker moved to approve the renewal Innkeeper applications for Farmington Motel, Mount Blue Motel and Colonial Valley Motel, renewal Lunch Wagon Permit applications for RJ's Hot Dogs and Grantlee's Mobile; Andrew Buckland seconded.

# **ITEM 3:** To Confirm the Employment of Seth Noonkester as the Assistant Director of Parks and Recreation

Richard Davis announced that Seth Noonkester has been hired as the new Assistant Director of Parks and Recreation, and turned introduction over to current Assistant Director Matthew Foster. Mr. Foster explained that there were 23 applicants for the position, which a committee of 4 reviewed and interviewed 6. Mr. Foster reviewed the committee members and Mr. Noonkester's background. He pointed out that all of Mr. Noonkester's references were great and his background check revealed no issues. Seth Noonkester was present and further reviewed his background.

Andrew Buckland moved to confirm the employment of Seth Noonkester as the Assistant Director of Parks and Recreation; Stephan Bunker seconded.

# ITEM 4: To Take Action with regard to the Proposed Wilton Road Traffic Pattern Changes

Richard Davis stated that this matter has been before the Board before and a public meeting was held several weeks ago with a power point presentation by a traffic engineer from the Maine Department of Transportation (MaineDOT). Mr. Davis pointed out the reports provided to the Selectmen by the heads of the Public Works, Police and Fire Rescue Departments, and the map displayed on a side table which indicates the proposed lane changes. Public Works Director Denis Castonguay, Police Chief Jack Peck, and Fire Rescue Chief Terry Bell explained how the proposed changes would affect operations and emergency response of each of their departments. Comments were heard from Selectmen Michael Fogg, Andrew Buckland and Stephan Bunker, Clayton King, Dick Brooks, Willard Hatch, Robert Waller, Dennis O'Neil, Nancy Porter, Lloyd Smith, and Jan Roberts. Facts, questions, concerns and suggestions included: why are the lanes being changed from four to two; there are only four sections of the 2.8 mile stretch of road that are being proposed to be reduced from four to two lanes for the purpose of improving safety issues; the traffic engineer stated at the Public Hearing that if the proposed traffic pattern is installed and is deemed to be unsuccessful the lines can be painted over, returning the road to its original pattern - it was pointed out later in the meeting, however, that the Town would be responsible for the very costly expense of repainting the traffic pattern; Willard Hatch presented information on the petition that he initiated, as well as traffic vs. accident statistics that he obtained from MaineDOT; what is the possibility of installing barriers down the center to eliminate left hand turns and instead create turnaround areas with traffic lights; safety issues concerning tractor trailers turning into businesses and/or trying to merge into traffic in the two lane sections; distracting signs/devices used by businesses to attract business; fear that the present inappropriate use of turning lanes as travel lanes will only get worse if a two-lane pattern is

implemented; the perception that there is more concern about speed than for safety; fear of change; there will be breakdown lanes in the two-lane sections; most likely there will be two less years wear of the asphalt in the two-lane sections and there will be more maintenance; sewer manhole covers in the two-lane sections will be out of the travel lanes; it would have been preferable for MaineDOT to have presented more than the one plan; education on distracted driving is needed; it was reiterated that there are no "bricks and mortar" changes, only paint changes which can be returned to the original pattern, albeit at an enormous expense to the Town; it was suggested that lane change signs strung above/across the road would be more visible and less maintenance than painted signs on the road which tend to wear off quickly; alternative suggestions focused on public safety are needed; signage identifying certain traffic issues; the problem with the current traffic pattern/issues cannot be corrected by writing traffic tickets.

Michael Fogg moved to take no action in regard to the proposed Wilton Road traffic pattern changes and leave the existing pattern as it is; Andrew Buckland seconded.
