Notice to Applicants

1. Under NO conditions may an applicant/agent/contractor begin a project requiring Soil Erosion Control/Storm Water Management Permit approval until the Planning Board or CEO has met to consider the application and has subsequently approved said project.
2. Applications must be submitted to the Code Enforcement Office with sufficient lead time prior to anticipated start date. If the proposal requires Planning Board review, the Board may deem that site visit is necessary or they may require a public hearing. Applicant/contractor/seasonal or other time constraints, and/or last-minute applications, will not be a factor in the considerations by either the CEO or Planning Board in making their decision.
3. An After-the Fact (ATF) application must be filed with the Code Enforcement Office for any project which was commenced before receiving approval and all project operations shall immediately cease. The fee for an ATF application is \$100.00 which must be payable before the application is scheduled for review.
